Residents may stay 12 to 18 months to heal and learn skills necessary for living empowered, successful lives free from abuse.

4b (Code:) (Expenses \$ 258,733. including grants of \$) (Revenue \$) Women's Program - We keep the two healing principles of safety and empowerment ever before us, provided in a loving, grace-centered environment. We have 19 years of experience in providing services to victims of domestic abuse to heal from their emotional wounds.

4c (Code:) (Expenses \$ 70,353. including grants of \$) (Revenue \$) Children's Program - With so many single mothers in our programs, The Dwelling Place also provides programming for their children. All the children in our homes receive ongoing case management, mental and behavioral health services, individual trauma therapy, and age-appropriate educational services to help them heal.
